## Town of Hamden Town Board Meeting of August 3, 2022

Superintendent of Highways Lenci reported that his department installed a sluice pipe on Stevens Road. Roads have been marked for ditching and culvert repairs. Carmen and Stevens Roads are on a list to be stoned.

Deb Renwick from Wayne Bank came to the board and presented a baseball diamond shadow box with Hamden baseballs form past years to the Town. The board thanked Deb for her generosity.

Wastewater report in Hamden reported a daily flow in of 6,441 gallon and about 200,000 for the month.

The land closing has been completed from the Town of Hamden to Placek for unneeded property in the Water District number 2.

The damaged walkway at the park has been repaired.

Gas, diesel fuel, and heating oil was bid out and the following were accepted for the upcoming year. 1. Ethanol free gas to Mirabito for a fluctuating price of \$4.19, 2. Propane bid to Mirabito for a bid of \$1.98 fluctuating, 3. Diesel and kerosene awarded to Mirabito for a low bid of \$4.13 and \$4.73 respectively and at a firm price. 4. Heating Fuel awarded to Allison Oil at a fluctuating price of \$4.29 per gallon.

Bids were received on a stream stabilization project on West Terry Clove and awarded to LaFever Excavating of Bovina for \$29,280.

## Delaware County Board of Supervisors Meeting of August 24, 2022

A resolution was approved in accepting a grant in the amount of \$5,000 from Cornell Cooperative Extension to the OFA Tai Chi for Arthritis Program.

A resolution was approved in transferring funds from the Current Recordings fund to the Equipment line in the Sheriff's office to purchase a desktop computer for the pistol clerk for \$1,981.

A resolution was approved in the Social Services Department to transfer funds from the Medical Services line to the Committee on Special Education for \$110,000. The current budget allotted funds for two children in that program and we now have three. These are children that require special educational facilities.

A resolution was approved in Solid Waste to transfer funding from the Fund Balance to funds for disposal of C&D, tires, oil lube, and lease of mobile equipment all in the amount of \$199,000.

A resolution was approved in DPW to transfer funds from Personal Services to funds for fuel oil, propane, lube, and supplies in the amount of \$250,000.

A resolution was approved to decrease the contract by \$53,224 on the Knox Avenue, Downsville bridge project. Total project cost will now be \$795,000.

A resolution was approved to authorize the publication of a public hearing regarding the community development block grant program administered by Economic Development. The hearing will be on September 28, 2022 at 1 pm.

A resolution was approved to dispose of 4 vehicles no longer needed for use. (2007 Chevy Malibu, 2009 Jeep Cherokee, 2014 Ford Fusion, and a 2014 Ford Focus).
